Sub: Maharashtra University of Health Sciences, Nashik - Renewal of recognition of MS(OBG) qualification for 08 seats in respect of students being trained at Armed Forces Medical College, Pune.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 01/10/2015 considered the Compliance Verification Assessment Report (June, 2015) along with the Council Assessor's Report (May, 2014) on the physical and other teaching facilities available at Armed Forces Medical College, Pune for Renewal of recognition of MS(OBG) qualification for 08 seats under Maharashtra University of Health Sciences, Nashik and the Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (June, 2015) along with the Council Assessor's Report (May, 2014) and decided to recommend to the Central Government that recognition of MS(OBG) qualification for 08 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Armed Forces Medical College, Pune be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
