5. The rates offered will be clearly mentioned for each firm and must be inclusive of all taxes. The rate of tax/VAT will also be mentioned in the quotations.
6. Quotation must reach to this unit at HQ Coord office on or before **21 Jul 2016** addressed to the Commandant, AFMC, Pune – 411 040 in a sealed envelope. Rate Enquiry No. and date should be mentioned on envelop.
7. **Quotations will be opened on 22 Jul 2016 at 1430hrs in the Dept of Pathology** by a board of officers. Your representative is welcome to attend the opening the quotations.
