4. Quotation must have all the details of the manufacturer, MRP, basic rate, taxes and rates offered to this institution.
5. **The basic rates offered will be clearly mentioned for each item. Subsequently the rate of taxes/VAT has to be mentioned separately in the quotation.**
6. Quotation must reach to this unit at HQ Coord office on or before **14 Nov 2016** addressed to the Commandant, AFMC, Pune – 411 040 in a sealed envelope. Rate Enquiry No. and date should be mentioned on the envelop.
7. **Quotations will be opened on 15 Nov 2016 at 1430hrs** in the Dept of Pathology by the board of officers. Your representative is welcome to attend the opening the quotations.
8. Supply should be ensured with in stipulated period maintained in the supply order. **PBG clause will be invoked for non-supply of items as per the supply order.**
